- We encourage ALL women Veterans and Veterans with families to attend.
- You may bring your pet(PS). The SPCA will provide veterinary and kennel services.
- **NO WEAPONS, DRUGS (INCLUDING MEDICAL MARIJUANA) OR ALCOHOL ALLOWED.**

(There will be an “Amnesty Box” for weapons and drugs/alcohol on site. If you bring a weapon(s), drugs or alcohol to the event, you will be asked to store them off site or dispose of them in the Amnesty Box. If you refuse, you will not be allowed to enter. If you are found with a weapon, drugs or alcohol in our possession while on the premises, you will be escorted off the premises immediately.

- Please bring all medications you will need to take while at the Stand Down. We will store your medications (refrigeration if necessary) for you while you participate in the Stand Down.
- Clothing and hygiene items will be provided. We will have safe storage area for all your belongings to be kept while you are at the Stand Down. You will be given an identification tag when you place them in our secure storage.
- You are required to stay for the entire (3) day event if you sign up for all services including Court.
- If you sign up for **COURT SERVICES**, you will need to provide your own transportation to Stand Down on Sept. 29th. Transportation will not be provided for Court Day.

Registration packages can be picked up at the following locations: **Santa Cruz Veterans Center, VA Monterey/Seaside clinic, Monterey-Salinas-King City Veterans offices, and the Hollister Veterans Service Office.**
